

SCBA Annual General Meeting 2019

Minutes of the Annual General Meeting held at Andover Baptist Church on 11th November 2019.

1. Opening Devotions – Mike Mortimer, Association Moderator, welcomed everyone to the Annual General Meeting.

- 2. Apologies for absence 11 apologies had been received.
- 3. Minutes The minutes of the 2018 Annual General Meeting, held on 12th November 2018 had been previously circulated. These were accepted as a correct record.
- 4. Annual Report of the Directors/Trustees for the year ended 31st December 2018 An SCBA Annual Review had been distributed at the start of the day. Report from the Moderator – Mike Mortimer gave an overview of the highlights of 2018 including the new team and the new strategy groups. - 6. No further items were raised and the official part of the AGM was brought to a close.


The Regional Ministry team gave an update and snapshot on what has taken place in the last year.

The afternoon ended in worship and prayer.


